House elects its youngest premier



to make **Paetongtarn** Shinawatra the next as well as the youngest-ever prime minister of Thailand, Al Jazeera reported on Thursday. Paetongtarn succeeds Srettha Thavisin, who was removed from his post by a constitutional court ruling on Wednesday. Known by her nickname Ung Ing, Paetongtarn is the youngest child of billionaire tycoon Thaksin Shinawatra and is the third member of the family after her father and aunt to hold the nation's top job.

73 dead in conflict, says Houthi leader

Abdul-Malik al-Houthi, the leader of Yemen's Houthi group, revealed that 73 people have been killed and 181 injured since the beginning of their military operations against Israel in October 2023. Al-Houthi's statement, broadcast on the group's Al-Masirah TV channel, detailed the toll of what they call the "Promised Victory" battle. This campaign has coincided with increased military activity in the Red Sea region, including attacks on vessels the Houthis claim are linked to Israel.

PAKISTAN

Government 'tinkered' with internet

After months of speculation about a potential 'firewall' causing internet disruptions in the country, Pakistan's IT minister confirmed on Thursday that the government was indeed upgrading its 'web management system' to "address cybersecurity threats," Dawn reported. Although Shaza Fatima Khawaja, the Minister of State for Information Technology and Telecommunication, used vague language, this was the first official admission of the government's actions. These actions had been blamed for various issues, including slow browsing speeds, arbitrary social media and WhatsApp disruptions.

'West helped in Ukraine incursion'

An influential aide to Russian President Vladimir Putin said on Friday that the West and the US-led NATO alliance had helped to plan Ukraine's surprise attack on Russia's Kursk region, something Washington has denied.

Influential veteran Kremlin hawk Nikolai Patrushev dismissed the Western assertions in an interview with the Izvestia newspaper.

"The operation in the Kursk region was also planned with the participation of NATO and Western special services," he was quoted as saying. "Without their participation and direct support, Kyiv would not have ventured into Russian territory"

Meanwhile, Mikhail Sheremet, a member of the Russian parliament's defence committee, was quoted by RIA saying, "One could come to the conclusion that the world is on the brink of a third world war.'

Students mull floating party

Student demonstrators who ousted Prime Minister Sheikh Hasina have rejected calls from Bangladesh's two main political parties for quick elections and are considering creating their own party to cement in place reforms, according to interviews with four protest leaders. They hope to avoid a repeat of the last 15 years, in which Hasina ruled the country of some 170 million with an iron fist.

That was until June, when a

handful of students – most in their early-to-mid 20s - began organising demonstrations against a law reserving coveted government jobs for certain segments of the population. Within weeks, Hasina's government was swept away by an upswell of popular anger at the brutality of its crackdown on anti-quota protesters. At least 300 people were killed in the single largest bout of violence since Bangladesh's war of independence from Pakistan in 1971. The movement was hailed as a Gen Z revolution, spurred by young Bangladeshis' anger at years of jobless growth, allegations of kleptocracy, and shrinking civil liberties.

An interim government headed by Nobel Peace laureate Muhammad Yunus, which

includes two student leaders in senior positions, now runs the country. For most of the three decades, Bangladesh has been governed either by Hasina's Awami League or the Bangladesh Nationalist Party of her rival Khaleda Zia, both of whom are in their 70s. Student leaders are discussing forming a political party to end the duopoly, said Mahfuj Alam, who chairs a committee tasked with liaising between the government and social groups such as teachers and

A decision would be made in about a month, the 26-yearold law student told Reuters, adding that protest leaders wanted to consult widely with ordinary voters before deciding on a platform."People are really tired of the two political parties. They have trust in us," he said, at the gates of Dhaka University's Arts Faculty. Tahmid Chowdhury, another student coordinator, said there was a "high chance" they would form a political party. They were still working out their programme, though he said it would be rooted in secularism and free speech.

"We don't have any other plan that could break the binary without forming a party," said the 24-year-old graduate student. The student leaders in interim government have not specified what policies they intend to pursue, beyond sweeping institutional changes - such as reforming the electoral commission handpicked by Hasina - to avoid another spell of authoritarian rule. "We are totally in uncharted waters, both legally and politically," said Shahdeen Malik, a constitutional expert.

New case filed against former PM

> A murder case was filed against Bangladesh's former Prime Minister Sheikh Hasina on Friday over the death of a teacher, the latest in the string of cases filed against her after her ouster.

The case was filed against Hasina and Awami League General Secretary Obaidul Quader Bogura. Ninety-nine other local leaders and activists of her party were also sued in the case filed with Bogura Sadar Police Station over the murder of 35-year-old Selim Hossain, a resident of Palikanda village of Shibganj upazila on August 4.

On August 4, Hossain joined students' protest in Bogura's Satmatha area. According to the complaint. AL leaders and activists allegedly hacked Hossain to death with sharp weapons.

His brother alleged the killing was ordered by Hasina and Quader.

Israeli settlers torch village in Palestine, I dead

Dozens of Israeli settlers have set fire to houses and cars in a village in the occupied West Bank, with the Palestinian health ministry saying at least one person has been killed. The settlers - some of them wearing masks - threw rocks and Molotov cocktails as they attacked the village of Jit, near the town of Nablus, on Thursday evening, the Israel Defense Forces (IDF) said.

The Palestinian health ministry said a local villager in his early 20s was killed and another person critically injured in the chest. The IDF said it was examining the report of the fatality. Israeli political leaders condemned the attack, pledging to punish the perpetrators. One Israeli national was detained in Jit, the IDF said.

Footage has emerged on social media purportedly showing houses and vehicles set ablaze in Jit late on Thursday. Plumes of smoke are seen rising above the village. Israeli Prime Minister Benjamin Netanyahu's office said in a statement that "those responsible for any criminal act will be caught and prosecuted".

Israeli President Isaac Herzog wrote on X: "This is an extreme minority that harms the law-abiding community of settlers and the settlement as a whole and in the name and status of Israel in the world during a particularly sensitive period. "Law enforcement officials must act immediately" to bring those responsible to justice, he added.
